

#### Fall 2015 Conference Class Descriptions

**Legislative Updates (Judicial Organization & Theory)** Judge A. Carl Myers will speak on New Legislation from the 2015 Oregon State Legislative Session, particularly those bills affecting local courts and state trial courts, including HB 3399. His presentation will include explanations on how some important bills got passed. He will also speak to some interesting bills that did not pass and legislative trends that may indicate issues in upcoming sessions. There should be time for questions and general discussion.

**Rap Sessions (Legal/Court Procedures)** Rap sessions are being held after Legislative Updates and we should have plenty to discuss! Come prepared with questions you would like to ask your peers. This is the perfect time for asking each other how the business of court is handled in different jurisdictions.

**Workplace Communication (Personnel/People Skills)** Sharron Noone will describe the differences between leaders and managers and the skills needed by supervisors as they work with diverse needs of employees. Short assessments and group discussion will aid participants in using the information.

**MSU - Leadership (Personnel/People Skills)** Leadership is an exciting opportunity to make a difference in your courts, and to impact the way your courts' function. Dr. Rainosek is famous for making a day long transformative change leadership program an exceptional experience. She will provide participants a significant amount of knowledge about different leadership approaches, and will particularly go into some depth with The Leadership Challenge (TLC) by Jim Kouzes and Barry Posner. TLC is in seventy countries, and TLC materials have been translated into 21 languages. Dr. Rainosek is a Certified Master of TLC.

Every employee of a court system is a leader; often they simply do not realize how they lead daily. Dr. Rainosek will give you excellent examples of how to teach each of your staff and other professionals you encounter how to lead and how their leadership supports a high performing court system. Jackalyn loves to make leadership fun. She also believes that there are enough challenges in courts that leaders must know how

to encourage, engage, and motivate others to work collaboratively with others to produce the amount of work that is required in each court.

Participants will walk away with sufficient information about the Five Practices of Exemplary Leadership of TLC (Model the Way, Inspire a Shared Vision, Challenge the Process, Enable Others to Act, Encourage the Heart), knowledge and an evaluation about how to increase engagement in the courts, a self-assessment concerning your strengths and areas of challenge as a leader, clarity about the difference between leadership and management, how leadership is defined, and some comments about other approaches to leadership from Steven Covey (The Seven Habits), Daniel Goleman (Emotional Intelligence), and multiple leaders comments about Ethical Leadership. Experience and knowledge comes from seeing other leaders exhibit the practices of exemplary leaders; therefore, the participants will have a chance to see a few videos that show what actions exceptional leaders take. Leadership for Transformative Change is a compressed three day program into one day, and gives you as court administrators a burst of energy to support your particular court moving forward.

The Unbreakable Rules of Marketing (Personnel/People Skills) Are you asking yourself why would you need to know anything about marketing? You may be thinking, "I'm not a marketer, so why would it matter?" Here's the thing...you ARE a marketer. We all are. And we are in a constant state of marketing, both on a personal level and a professional level. We use marketing when communicating with supervisors, staff, City Council, press, members of the community, and patrons. The more you're aware, the more you can control how you create a better experience. Not only for yourself, but for others as well. Marketing. It's for everyone.

**RegJIN (Operational Systems Management)** This course is an overview of RegJIN. Regional Justice Information Network (RegJIN) Records Management Systems (RMS) project replaces the existing Portland Police Data System (PPDS), along with increasing the integration between its various components and enhancing its core capabilities.

The new RegJIN RMS will display and share crime related information with over 43 law enforcement agencies that operate within the Portland metropolitan area. The new RMS will enable data sharing within and between the various regional law enforcement agencies, expanding the repository of critical crime data while ensuring data confidentiality in a secure, highly available environment. Half of the law enforcement officers in the state of Oregon were on board to "go-live" on April 14th, 2015. To break it down, that's about 3,000 officers/deputies and nearly 10,000 total users.

**Conflict of Interest (Judicial Organization & Theory)** Objective: To provide education and direction regarding Oregon Government Ethics law located in Chapter 244. Explain how provisions in ORS Chapter 244 may apply to duties performed as a "public official". In addition, the training will discuss the administrative rules and how they apply to the provisions within Chapter 244. Attendees will:

- Recognize that they are "Public Officials" as defined in ORS 244.020(14) and as such are bound by the provisions in Chapter 244.
- Demonstrate knowledge of the application of the law and when and how the application of exceptions to the rule applies.
- Be able to identify what is prohibited by the rule.
- Recognize others to whom the rule applies.
- Have the opportunity to engage in discussion.

**Cop Talk: Youth and Drug Trends (Elective)** This presentation will focus on youth drug trends, what is out there, where to find it, how youth abuse it, where they are hiding it and more. There will be visual aids and is designed for the general public to promote awareness so they too can recognize indicators of potential substance abuse.

**DMV (Legal/Court Procedures)** We will have a panel of people from the DMV to speak to us and answer our questions about DMV policies and procedures. Be ready to bring your questions for DMV experts!

## FALL (odd years) ELECTIONS IOB DUTIES OF OFFICERS AND DIRECTORS

The following are position descriptions for the (odd year) Officer and Director positions that will be open for election at the OACA Fall Conference.

#### **President:** The President shall:

- preside at the annual meeting of the Association, at any special meeting or conference of the Association and at all meetings of the Board of Directors;
- except as otherwise provided in the By Laws, appoint the chairperson and members of all standing and special committees;
- be an ex-officio member of all committees; and be signatory on any accounts in financial institutions for the Association, and on any contracts or commitments made by the Association or the Board of Directors.

#### **Education Vice President:** The Education Vice President has primary responsibility for:

- researching and recommending to the Board, conference themes, keynote and workshop speakers, curriculum design, and organization of the educational program for all conferences;
- conducting surveys of the Association membership and all Oregon court judges and staff regarding educational needs and preferences;
- collecting and analyzing the conference session evaluations to maintain the highest possible quality of educational programs at conferences;
- organizing and managing the educational program for all conferences including negotiation with speakers for fees and expenses, recruiting speakers and hosts for all sessions;
- working with the Education committee and other volunteers to recommend applicants for scholarships and all levels of Certification of the Association, acquiring MCLE credits for all conferences, and making certain all membership constituencies are served through conference programs.

The Education Vice President shall assist the President and other Vice Presidents in the discharge of Association matters and in the absence of the President shall assume responsibility for the duties of that office. The Education Vice President is the chair of the Education Committee.

#### **Conference Vice President:** The Conference Vice President has primary responsibility for:

- researching and recommending conference dates, facilities and locations to the Board of Directors;
- negotiating contracts with hotels or conference facilities for all conferences and educational programs of the Association;
- organizing and managing the physical logistics of all events of each conference; working with the Conference Committee and other volunteers to plan banquets, fundraisers, social events, and the audio/visual set up of rooms for educational sessions which are part of the conferences.

The Conference Vice President shall assist the other Vice Presidents in the discharge of Association matters. The Conference Vice President is chair of the Conference Committee and a member of the Education Committee.

**The ECHO, Resolutions, and By Laws Vice President:** The ECHO, Resolutions, and By Laws Vice President has primary responsibility for:

- editing and managing the production of the Association's newsletter, The ECHO;
- maintaining a high level of quality and accuracy in The ECHO; working with The ECHO, Resolutions, and By Laws Committee in developing and reviewing proposals for Resolutions and changes in the By Laws to be brought to the Board of Directors and the Association's membership.

The ECHO, Resolutions, and By Laws Vice President shall assist other Vice Presidents in the discharge of Association matters. The ECHO, Resolutions, and By Laws Vice President is the chair of The ECHO, Resolutions, and By Laws Committee.

**Treasurer:** The Treasurer has primary responsibility for:

- maintaining the financial records of the Association;
- preparing and presenting to the Board a comprehensive, annual financial statement by April 1st of each calendar year;
- serving as Chairperson of the Finance Committee
- reporting on the current financial status of the Association oat each meeting of the Board of Directors and to the membership at the annual meeting
- depositing funds in such financial institutions as are designated by the Board of Directors in an account under the name of the Association;
- withdrawing account funds, execute checks or other drafts and disburse monies in support of official Association business or activities in accordance with the provisions of the By Laws;
- assist other Board members in the discharge of their duties.

**Directors:** All Directors are elected at large from the membership of the Association and are responsible for:

- serving as members of the Education Committee
- assessing the Association's educational needs
- developing and coordinating the educational goals, plan, and programs for the Association
- conducting membership surveys
- evaluating educational presentations
- perform other duties at the direction of the President of Board of Directors in furtherance of Association purposes
- assist other Board members in the discharge of their duties

One director shall be designated Director of Certification by the President and assigned the tasks of administering the Association's Certification Program including recommending persons to the Education Committee for Certification at a specific level. Other directors are assigned to a board officer.


